Temporary Membership Agreement

MISSION STATEMENT

STALWART CLEAN & SOBER will provide its members with a clean, safe, and sober living environment. As a service to the community, Stalwart Clean and Sober attempts to offer its unwavering partisan services to as many people as space and resources permit.

SOBER LIVING: Stalwart is supported in part by dues paid by people residing in a facility operated by Stalwart Clean & Sober. To support the goal of sober living environments, drug and alcohol testing may be conducted without prior notice to any member where there is reasonable cause to believe or suspect that substance abuse by that member is taking place. Any member who refuses to sign a release and authorize any drug or other substance testing will be subject to responsive actions including without limitation, termination of membership. This is not done for any reason other than to assure a substance-free environment for all residents and guests of Stalwart Clean & Sober. Termination of membership is cause for immediate termination of all privileges, including residency at Stalwart Clean & Sober. I hereby expressly authorize Stalwart Clean & Sober to conduct random drug and alcohol testing of me as they may, from time to time determine appropriate in supporting its intention of maintaining sober living environments. In connection with drug testing by Stalwart Clean & Sober I understand and agree that I hereby expressly waive all rights of protest, notice and rights afforded by the Privacy Act and I do further hereby expressly and unconditionally release Stalwart Clean & Sober from any liability of any nature in connection therewith.

PERSONAL PROPERTY: By signing below, I understand and agree that if for any reason I abandon any personal property at any facility operated by Stalwart Clean & Sober, I understand those items will be held for a maximum of 15 days from the first day that I do not pay my membership dues or have vacated the Stalwart Clean & Sober facility that I had occupied. After the 15th day my personal property may be disposed of at the sole discretion and in any manner deemed fit by the management, employees, agents and assigns and all other members of Stalwart Clean & Sober wherever located plus the owner of any real property leased by Stalwart Clean & Sober from and against any and all liability of any nature whatsoever in connection with such disposal of my abandoned personal property.

Notwithstanding the foregoing, I hereby unconditionally release and agree to hold harmless from and against any and all liability Stalwart Clean & Sober, its officers, directors, management, employees, agents and assigns and all other members of Stalwart Clean & Sober wherever located from and against any and all liability of any nature whatsoever in connection with the damage to or loss of any of my personal property that I bring into Stalwart Clean & Sober as well as the damage or loss of any personal property brought into Stalwart Clean & Sober by any guest or invitee of mine.

WEEKLY MEMBERSHIP DUES: I understand and except that Stalwart Clean & Sober provides a clean, sober and safe living environment for men who desire to and are working with a 12 step program. Membership is weekly. In exchange for Stalwart Clean & Sober providing me membership in its sober living environment, I agree to pay a weekly rate of \$200.00. I understand this is a payment in advance for one week of membership and that my dues for temporary membership are due and payable every Friday without exception. In addition, I agree to pay in advance, a deposit in the amount of \$190.00. I understand this deposit will be refunded to me if I have remained a member in good standing of Stalwart Clean & Sober and provided I have not been discharged from Stalwart Clean & Sober for any reason inconsistent with the terms of my this agreement and my membership. I understand I must give one week's written notice prior to terminating my membership or vacating Stalwart Clean & Sober premises in which I reside. I also understand and agree I must remain a member in good standing for a minimum of 30 days from the time of my residency at Stalwart Clean & Sober to receive a refund of my deposit.

I understand and agree there that if my dues are three days late, I will be assessed a late fee of \$25.00. If I pay my dues on or before the 2nd day after there due date, no late fee will be assessed. This notwithstanding, I understand this does not constitute an extension of the due date for my dues. I understand my dues are payable every Friday without exception. I understand that if my dues have not been paid by Friday following the due date including all late fees, I will be asked to leave Stalwart Clean & Sober premises and my membership and all privileges there under will be terminated. I understand there will be no exceptions made to this policy.

SUBSTANCE USE, POSSESSION. I understand that Stalwart Clean & Sober is a clean, safe and sober living environment. I promise and agree to completely abstain from the use of all drugs and chemicals including alcohol. I understand the only drugs I can use are those prescribed by a medical doctor for physical condition. I understand I must provide Stalwart Clean & Sober with a copy of my prescription for any drug so prescribed, and that in any event, I cannot take any prescription for any physical, emotional or mental condition that may alter my mind or mood altering chemicals will be allowed to reside in, visit or be on the premises of any facility of Stalwart Clean & Sober. I agree to never possess any illegal drugs, alcohol, weapons of any nature including without limitation firearms, knives or explosives, including fireworks.

MEMBER CONSENTS: I understand and agree that failure to abide by any of these rules regarding smoking, alcohol, drugs (prescription or otherwise), and weapons will be grounds for immediate termination of membership.

I understand and agree to participate in household chores on a regular basis including cleanup and other yard maintenance at Stalwart Clean & Sober facility in which I reside. I agree to be responsible for keeping my sleeping and living accommodations in a healthy, clean, orderly and safe manner.

I understand and agree that in the event my membership is terminated because I have violated any term of this agreement, my deposit will become non-refundable.

I understand and agree to maintain employment or actively seek employment. Should I become unemployed, I will notify the Stalwart Clean & Sober Manager immediately.

I understand and agree that my residency at a facility operated by Stalwart Clean & Sober will be with other people. I agree to co-exist peacefully with other people living at or around Stalwart Clean & Sober. I agree not to leave my personal property anywhere in or about the facility operated by Stalwart Clean & Sober except in my sleeping room or in a designated storage area as pre-approved by the management of Stalwart Clean & Sober.

I understand the Stalwart Clean & Sober facility in which I reside is not to be used for commercial purposes or conducting any commercial activity for which profit from such activity is intended or realistically anticipated.

I understand and agree that in no way is physical violence or verbal abuse tolerated in or at Stalwart Clean & Sober and can be the basis for immediate termination of membership. I hereby released the management, house, all officers, directors, employees, agents and assigns of Stalwart Clean & Sober and the owner of the real property in which Stalwart Clean & Sober is situated, at any facility of, Stalwart Clean & Sober, from and against any and all liability or responsibility for any damage, personal injury, or loss of personal property that I may sustain in connection with my membership or my living in the Stalwart Clean & Sober living environment. This constitutes a full and unconditional release and I hereby expressly waive any right I may have to make claim or assert any cause of action to the contrary.

OTHER CONDITIONS of MEMBERSHIP: I understand and agree that I live in the Stalwart Clean & Sober living environment as a temporary member and not as a tenant. I have no rights of tenancy and no rights of tenancy are expressed or implied in this agreement, or by my payment of dues. I understand in the event I violate this membership agreement, and as a result am asked to vacate, that I will do so without requirement of any legal process. I understand and agree that any willful material misrepresentation at any time by me shall be the basis for immediate termination of my residency membership and that Stalwart Clean & Sober will retain my full deposit.

ENTIRE AGREEMENT: This agreement contains all representations and the entire understanding and agreement between Stalwart Clean & Sober and the undersigned member. All agreements whether written or oral, originating before the date and time of execution of this agreement are canceled, superseded by and merged in total by this agreement.

WAIVER of DEFAULT: The waiver of Stalwart Clean & Sober of any default in the performance or of any provision or condition herein shall not be construed to be a waiver of any preceding or subsequent default of the same or any other provision or condition contained herein.

GOVERNING LAW, JURY TRIAL WAIVER and VENUE: This agreement shall be interpreted, construed and enforced in accordance with the laws of the State of California. The parties understand, consent and agree to waive their right to a jury trial in any matter arising out of this agreement and this waiver is absolute and unconditional. Further, the parties understand and agree that the venue of any litigation arising out of any dispute concerning this agreement shall be in the courts of Santa Barbara County, California and no litigation shall be commenced in any other court in California or elsewhere. In the event either parties brings any unsuccessful litigation against the other, then the prevailing party shall be reimbursed by the unsuccessful party for all of its attorney's fees, travel expenses and other litigation costs of any kind.

HEADINGS: The titles and headings of the various paragraphs in this agreement are intended solely for convenience or reference and are not intended, modify or place any interpretation upon any of the provisions of this agreement.

SEPARABILITY: If any part of this agreement is determined to be illegal or unenforceable, all other parts shall be given effect separately and shall not be so affected.

Policies and Procedures

These are the rules and regulations that govern our conduct at Stalwart and protect the integrity of our purpose.

1. Complete abstinence from all non-prescribed or conscious altering drugs and alcohol.
2. All monies will be paid on time.
3. Assigned chores will be completed **daily!**
4. Mandatory attendance at all house meetings.
5. Attend house prescribed outside 12 step meetings weekly.
6. Continuing work with 12 step sponsor and/or spiritual mentor.
7. All personal areas will remain clean and organized.
8. No Guests in sleeping areas. No guests of opposite sex in houses.
9. Residents will shower everyday.
10. Comply with house mandated curfew.
11. No uncommonly loud noises or music at any time.
12. No storing of excessive personal belongings.
13. No smoking in buildings.
14. House phone calls are to be limited to 15 minutes.
15. No parking on property
16. Violence or threats of violence. Or any theft will result in immediate termination.
